Executive Summary

Natural Resources Wales (NRW) maintains a shared interest in the Register of Historic Landscapes (RHL) with Cadw and the four Welsh Archaeological Trusts.

Registered Historic Landscapes are a material consideration in the planning process, specialist planning advice is needed for those developments that may have more than a local impact on the RHL.

The four Welsh Archaeological Trusts (WATs) provide advice relating to the RHL to planning authorities along with other specialist historic environment planning advice.

NRW and the four WATs have signed a Memorandum of Understanding (MoU) that outlines how the organisations will collaborate and co-operate for the benefit of Wales' historic and natural environments. Section 5.2 of the MoU sets out that 'NRW will help support the WATs in building capability and capacity to provide advice on historic landscapes'.

The Glamorgan Gwent Archaeological Trust (GGAT) provides advice in relation to planning across the South East region of Wales, serving 12 unitary authorities (Blaenau Gwent, Bridgend, Cardiff, Caerphilly, Merthyr Tydfil, Monmouth, Neath Port Talbot, Newport, Rhondda, Cynon Taff, Swansea, Torfaen and Vale of Glamorgan). This area contains 13 Registered Historic Landscapes (8 Outstanding and 5 Special).

This report contains a summary of data collected for the period 1 March 2018 to 26 March 2019 on planning applications within the 13 Registered Historic Landscapes (RHLs) within the Glamorgan Gwent Archaeological Trust's geographic area.

During this period 431 planning applications were recorded as falling within the 13 RHLs identified above, none of these were of a form or scale that led to a recommendation for an Assessment of the Significance of the Impact of Development on the Historic Landscape (ASIDOHL). Natural Resources Wales (NRW) maintains a shared interest in the Register of Historic Landscapes (RHL) with Cadw and the four Welsh Archaeological Trusts.

During this same period there was one planning appeal within the Gwent Levels which was of a scale to impact the Registered Historic Landscape. This was (WAT Ref; NEW1415) APP/G6935/A/3150137 which related to a solar scheme at Llanwern.

No developments have been identified that were considered to be of such a scale that they would have more than local impact on an area of the Register.

This report contains a summary of data collected for the period 1 March 2018 and 26 March 2019 on planning applications and subsequent planning related works within the 13 Registered Historic Landscapes (RHLs) within the Glamorgan Gwent Archaeological Trust's geographic area.

The Trust attended the Annual MoU Review Meeting 2018 which provided an opportunity to discuss matters relating to the RHL as required.

In this reporting period the Trust undertook internal training for 7 staff on RHL management and the use of ASIDOHL in planning applications. The Trust also attended a Severn Estuary Partnership workshop and made representation in regard to the significance of the Gwent Levels RHL.

In March 2018 the Trust made a response to a consultation relating to a planning appeal (this was WAT Ref; NEW1415 PINS Ref: APP/G6935/A/3150137) for a Solar Farm at Llanwern, which is within the Gwent Levels RHL. As the appeal related to an application which was of a scale that it was considered to have an impact on the Registered Historic Landscape, an Archaeological Desk Based Assessment and ASIDOHL assessment as part of an Environmental Statement had been submitted in relation to this application. The Trust noted that the appeal supporting information had failed to correctly assess the impact of the proposed development on the buried archaeological landscape, which in and of itself forms a key significance of the Gwent Levels RHL. Amended documentation was submitted, and a mitigatory process was recommended regarding the buried archaeological resource. It falls within Cadw's remit to manage the ASIDOHL process within the RHL where an ES is undertaken. The Trust subsequently attended an appeal hearing in relation to this application for a Solar Farm and further clarified the impact of the proposed development on the buried landscape of the Gwent Levels RHL. Neither Cadw nor NRW attended the day of the hearing that considered the buried archaeological resource, setting and heritage matters.

In reviewing the result of this appeal the Trust has revised our assessment of the impact of developments of such a scale within the Gwent Levels RHL for the purposes of this reporting to reflect more accurately the picture of change in respect to the buried landscape of the Gwent Levels RHL. We now note that applications of such a scale to require archaeological mitigation do have an implication for the Gwent Levels RHL (see Table 3).

1.1.1. Data gathering & general trends

During the reporting period 431 planning applications and one planning appeal of significance to RHL were recorded as falling within the 13 RHLs in the trusts' geographic region, none of these were of a form or scale that led to a recommendation for an Assessment of the Significance of the Impact of Development on the Historic Landscape (ASIDOHL). However, the remit of the WATs in providing advice to local planning authorities in regard to ASIDOHL assessment is limited. Cadw provided the following specific advice in this regard in June 2017 (letter from Dr K Roberts to Welsh archaeological trusts):-

“Planning advice with respect to Registered Historic Landscapes.

Planning Policy Wales (November 2016), 6.5.27 states:-

“Information on the register of historic landscapes in Wales should be taken into account by local planning authorities in considering the implications of developments which meet the criteria for Environmental Impact Assessment”.

National Policy is that the impact of a proposed development on the historic landscape will only be a material consideration in the determination of a planning application when an environmental impact assessment is required. In such cases Schedule 4 I(iv) of The Town and Country Planning (Development Management Procedure) (Wales) (Amendment) Order 2016 indicates that The Welsh Ministers (i.e. Cadw) are the Statutory Consultees on this issue.

Planning Policy Wales (November 2016), 6.5.28 notes that:-

“Cadw and Natural Resources Wales have issued a ‘guide to good practice’ on using the register of historic landscapes. It includes a method for assessing the effects of proposed development on an area on the register of historic landscapes (ASIDOHL2). This method should be followed by applicants when preparing the relevant part of the Cultural Heritage chapter of their Environmental Statement”.

Thus a development inside a Registered Historic Landscape which requires an Environmental Impact Assessment will need an ASIDOHL to be prepared as part of the Environmental Impact Assessment. Consequently as Cadw are the statutory consultees for this aspect of the planning application they will also act as the Curator during the preparation of the ASIDOHL. We would therefore be grateful if you could inform any consultant working on an ASIDOHL for inclusion in an Environmental Impact Assessment that they need to consult and deal directly with Cadw.

The one exception to the above rule is where LPAs have included policies protecting Registered Historic Landscapes in their Local Development Plans. In these areas the impact of proposed developments on the Registered Historic Landscape may be a material consideration in the determination of a planning application even when an Environmental Impact Assessment is not required. In such circumstances, we would expect the relevant WAT DC section, in their role as the archaeological advisors to the LPA, to provide advice including consideration of the impact on the Registered Historic Landscape.”

The total number of planning applications (or subsequent works flowing from planning applications) per Registered Historic Landscape are shown in Table 1 below. It is apparent that the RHL with the highest number of planning applications is the Merthyr Tydfil (153), followed by The Rhondda (99). Other RHLs with higher numbers of planning applications were the Lower Wye Valley (30) and the Gwent Levels (17). The RHLs with the highest number of planning applications tally with those authorities where we would normally expect to experience the highest demand for the provision of specialist planning advice.

**It should be noted that the record made for Gower included that area identified on the Register, and that area characterised within the Gower AONB, however this data has been disaggregated for the purposes of reporting. However only applications those within the area of the Register are considered in this report.*

The total number of applications split by category of type/nature of development can be seen in Table 2 below. The highest proportion of applications were for Extensions (129) followed by Miscellaneous (96), the next highest was Conversion/change of use (45). This was followed by Residential/Mixed-use development (39), then Garage (29), and Single dwellings and Alterations (29). There was some difficulty in assigning these individual categories to complex planning applications where sometimes an application might encompass the erection of a single dwelling with associated vehicle access and demolition. For the purposes of this report the predominant category has been assigned.

1.1.2. Applications requiring further archaeological work in RHLs

Table 3 below provides a log of activities relating to the provision of planning advice associated with the 13 Registered Historic Landscapes in GGAT's region. The differing responses given in respect of these 432* applications is detailed here:

- 346 RHL Disc – applications only looked at as they were located within RHL and determined not to have any impact on the RHL or historic environment
- 10 DAR Disc – applications looked at for wider archaeological impact and determined not to have any impact on the RHL or the historic environment
- 37 Dar Disc + – applications unlikely to have significant impact on historic environment
- 3 LB Disc – applications unlikely to have significant impact on a listed building
- 2 Determined
- 2 Retention
- 5 Record – applications where a record of a building has been requested as a condition
- 1 Evaluation – where an application has been recommended for deferral pending the results of pre-determination archaeological investigative work
- 16 Section 24 (programme of archaeological work) – applications where a programme of archaeological work has been requested as a condition
- 3 Watching brief – applications where an archaeological watching brief has been requested as a condition
- 0 Consult Cadw – applications requiring Cadw's consideration
- 0 Discharge of condition – applications for discharge of conditions relating to archaeology

A new category of other has been added to this round of reporting to capture responses which do not fall into the above categories, for example Further Information Required, Re-consultation, Variations of Conditions and Formal Pre-Application Screening.

**It should be noted that the figures above total more than 432 as some application fall into more than one category of response and thus are recorded more than once.*

A significant proportion, more than 80%, of applications reviewed as part of this contract have been reviewed solely because they fall within RHL (346). These are in addition to applications which the trust would normally review as part of our archaeological planning management work. There is a clear need to build capacity to review those applications which are significant from an RHL perspective notwithstanding any other potential historic environment impact.

In the reporting period no developments have been identified that were considered to be of such a scale that they would have more than local impact on an area of the Registers. The full log of activity is set out in the following table.
